

# Spring Hill Fire Rescue & Emergency Medical Services District

## Ordinance 2009-02

An Ordinance of the Spring Hill Fire Rescue & Emergency Medical Services District here-by establishing a fee schedule for Services or Fines associated with Fire Inspections, Public Requests or other needs as may arrive within the Spring Hill Fire Rescue & Emergency Medical Services District; and providing for an Effective Date.

Special Request Hydrant testing .....\$65.00 first hydrant, \$35.00 each additional

Stand-by Fire Rescue Apparatus (Special Events)... \$200.00 per hour includes all stand-by personnel

False Fire Alarm .....3 alarms per 12 months (free)  
Class A Fee .....\$100.00 per alarm after 3  
Class B Fee .....Reserved  
Class C Fee .....Reserved

Conceptual Building Design Fee .... \$250.00 If application leads to a building permit. \$100.00 of this fee will apply towards the application.

Planning or Zoning Department Fire Review Fee .....\$125.00 Fee is not refundable

Building Department Fire Plans Fee (s) .... New or altered / modified construction based on square foot. (Includes Fire Hood/Coolers/Underground or other as deemed necessary by Hernando county Commercial permitting) (\$0.04 / sq ft)

### Fire Sprinkler Review

Up to 48 heads \$150.00 / test, 2 test minimum  
Over 48 heads \$0.04 / sq ft (+ min 2 test at \$150.00 each)  
Alterations of existing system \$150.00 / per test, min 2 tests

### Fire Alarm Fire Review

Up to 3 devices \$100.00 SHFR plus County portion for electric and administrative costs  
Over 3 devices \$150.00 SHFR plus County cost for electric permit and administrative costs

Where the inspection process requires more than a standard inspection additional fees billed @ hourly rate shall prevail.

Fire Hood Suppression .....\$125.00 / application  
Walk in Coolers ..... \$125.00 / application  
Plan Revision .....\$40.00 / hour

Acceptance testing over and above an open permit...\$40.00 / hour

Life Safety Inspection when requested for a special need or additional inspections on a project where required \$40.00 / hour

Open Burn Permit (including Inspection of Property)...\$100.00 / permit Commercial or Planned Development only

Residential Burning (Meeting State Requirements) .....\$25.00 / 7 day week

Fireworks Permit ..... \$500.00 / Event

Carnival / Festival / Open Public Assembly Permit (inspection)...\$125.00 /Event Permit obtained from Fire Department

New State Licensed Facilities...\$40.00 / inspection  
Includes: Group Homes, Adult-Living Facilities, New Residential or Commercial and Adult Daycare (1 follow-up allowed)

Parking or Blocking of Fire Lanes on Private property ...(Reserved)

Failure to Maintain Fire Lane Marking ... Violation of Florida Statutes (F.S.633)

Storage as Referenced in Section 18 ...1<sup>st</sup> Offense \$25.00, 2<sup>nd</sup> Offense \$50.00, each additional offense per FS 633.

Improper Storage of Dumpster/Combustibles ...\$25.00 / incident

Failure to Maintain Access Control Gates .....\$25.00 / incident after the first notice / year

Smoking in Posted (No Smoking) Areas.....\$25.00 / incident (individual)  
Allowing smoking in non smoking areas subject to FS 633 enforcement criteria

Violations of Chapter 633 ...As referenced by Statute

Consultation Fee's ...\$65.00 per hour (15 minute Increments)

Original Occupancy Certificates (Occupant Load) ...Free  
Replacement Certificate.....\$15.00

Failure to address violations/Annual Fire Inspections...1<sup>st</sup> & 2<sup>nd</sup> Inspection (Free)  
3<sup>rd</sup> Inspection \$25.00 / Violation  
4<sup>th</sup> Inspection \$35.00 / Violation

Final Visit for Non-Corrected Violations subject to 633 Florida Statutes.

Severability...If any section is ruled as un-constitutional then it shall not negate any other section, and each fee shall be enforceable.

All fee's and/or fines applied per this chapter shall be delivered or mailed to Spring Hill Fire Rescue & Emergency Medical Services District at 3445 Bob Hartung Court, Spring Hill, Florida 34606.
